Objectives:

- Enhance recycling practices and encourage recycling markets within the state to increase economic value of commodities to reduce the need for Department initiated remediation efforts.
- Improve reporting requirements to allow for enhanced detailed reporting of landfill diversion activities including recycling.
- Increase the State Solid Waste Reduction Goal.
- Align regulations with the Departments updated operating system.

CHAPTER 1 GENERAL PROVISIONS

- 1. Update purpose in .01 to include Recycling/Materials Management and Beneficial Use
- 2. Add/Update/Clarify Definitions in .03:
 - Clarify (85) "Materials Recovery Facility"
 - Clarify (112) "Recovered Materials"
 - Clarify (113) "Recovered Materials Processing Facility"
 - Clarify (114) "Recyclable Materials"
 - Clarify (115) "Recycling"
 - Clarify (133) "Solid Waste Management Facility"
 - Add and define "End Use manufacturing facility/End Use facility"
 - Add and define "Commercial Recycling"
 - Add and define "Residential Recycling"
 - Add and define "Diversion Goal/Rate"
 - Add and define "Diverter"
 - Add and define "Recycler"
 - Add and define "Contractual Waste or Recycling Hauler"
 - Add and define "Materials Brokers"

CHAPTER 3 PROCESSING AND RECYCLING

- 1. Update and clarify the Purpose and Applicability
- 2. Update the use of a form to apply for registration.
- 3. Clarify and update regulations to require renewal after 3 years.
- 4. Define registration modification and associated processes.
- 5. Require End Use Facilities, Diverters, Reducers, etc. facilities to register.
- 6. Add requirements relative to State Agencies and Educational Institution Registration requirements.
- 7. Update regulations to require weight to be measured in tons.

- 8. Update Exemptions to include de minimus amounts of recycling and specific types of operations. Allow for voluntary registration if exempt by rule.
- 9. Consider reporting of materials to count toward the diversion rate for those items that meet .02(3)(e).
- 10. Consider registration requirements for solid waste incinerators and waste to energy facilities and subject to Division 3 primarily for diversion reporting data.
- 11. Update Variances to be in line with current variance language.
- 12. Correct Terminology and usage of Revocation, Termination throughout the rules.
- 13. Consider the meaning of relative exemption allowed for holding an NPDES permit.
- 14. Allow for the coordination with other cooperative agencies to gain more complete data and/or to discontinue redundant data reporting.
- 15. Add details to define and detail BMPs for tipping onto a floor along with managing recyclables/contamination (most specifically at a permitted landfill).
- 16. Update the requirements to require less information on signage.
- 17. Update the storage limit requirements to speculative accumulation requirements listed in ADEM Admin. Code Div. 14.
- 18. Update rules relative to accumulation time frame to require certification (of compliance) on an annual basis.
- 19. Update reporting requirements from semiannual to annual reporting including details such as where the material was collected (drop-off, curbside, etc.).
- 20. Add requirement to track and report contamination rates.
- 21. Update closure situations.

CHAPTER 10 ALABAMA RECYCLING FUND GRANTS PROGRAM

- 1. Update Purpose to include Public Schools, Partnerships, and Universities
- 2. Update to include AEPACS for submissions.
- 3. Add details for multi-year phased grant applications.
- 4. Add details on amending/modifying awarded grants.
- 5. Update to ensure the SWMP includes focus on recycling.
- 6. Update relative to awarded grant amendments.
- 7. Update to ensure that "advanced funds" term is used consistently.
- 8. Update to a lower household threshold for category applications.
- 9. Update to change percentages for funds available for Category 1 and Category 2 applicants but include language that provides the Director enhanced flexibility to adjust the percentages of Category 1 and Category 2 funds if requests do not meet these thresholds.
- 10. Add "grant limited equipment" details for an entity that has received grant awards that has the closed/stopped recycling activities and define "Grant Limited Equipment".

CHAPTER 13 STATEWIDE SOLID WASTE REDUCTION GOAL

- 1. Update Purpose for possible inclusion in this chapter for conducting a comprehensive MSW study on a periodic basis to determine makeup of disposal stream.
- 2. Include in reduction calculation: scrap tire recycling, beneficial use land application, etc.
- 3. Update the Reduction Goal to 35% from 25%
- 4. Add details regarding the calculation of a recycling rate which should be a subset of the reduction goal.

5. Update to better define when the reduction goal evaluation should be conducted. Consider review at the Biennial Report time versus triennial basis.
